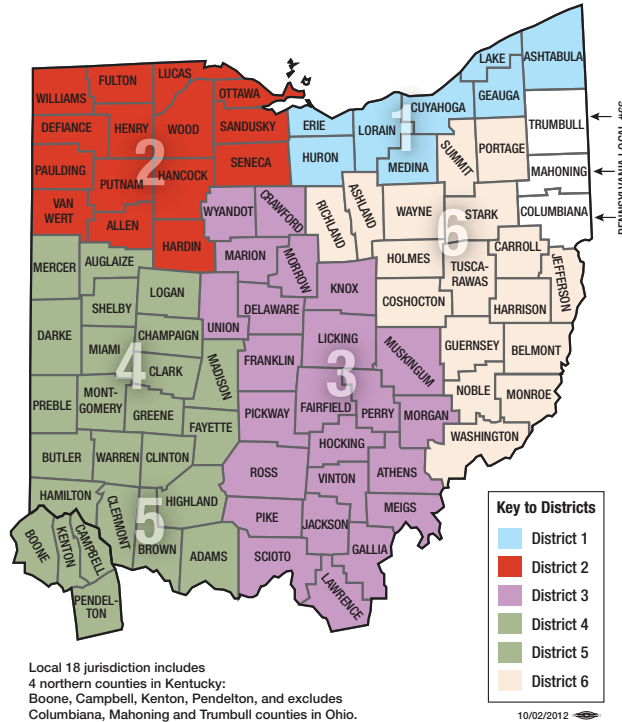
There is no fee associated with our application. Once you successfully submit your application, you will be scheduled for the entrance examination.

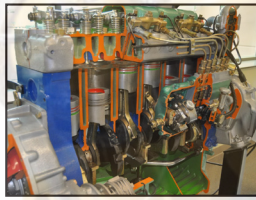

## What is a Maintenance Technician?

**Equipment Operators** are the people who operate the equipment used to build roads and bridges and assist in the construction of large buildings and other structures.

**Maintenance Technicians** are the people who maintain and repair the equipment used for these projects. With knowledge and training, you gain the experience and the ability to do what it takes to get the equipment back to its operational capacity, and back to being productive on the project.

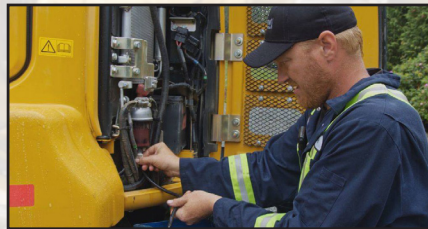
## Apprenticeship Program

Our Apprenticeship Program is an INDUSTRY SPONSORED and FUNDED, registered Apprenticeship Training Program.

This program was created to help meet the huge demand for mechanics in the construction industry. If accepted, you will receive intensive training in multiple areas at no cost to you.

The course will cover everything from shop and equipment manuals to engine, electrical, brake, power train and hydraulic systems.

To become a Maintenance Technician a person must complete four (4) years of apprenticeship training which includes a minimum of 1280 hours of classroom and related instruction and minimum of 4000 hours of employment.



## Selection Process

The number of apprentices needed varies from year to year for each of our districts.

The selection process is as follows:

Application  
Testing  
Interview  
Pre-Admission Orientation  
Indenture

## Qualifications Required to Apply

1. Applicants must be eighteen (18) years old by May 1, of the year that they are applying for entry.
2. Applicants must be able to read and do arithmetic well enough to progress in the classroom training and understand oral and written instructions.
3. Applicants must be eligible to work in the United States.
4. Applicants must be willing to work outdoors in any type of weather and be able to travel to distant work sites if required.
5. Applicants will receive a criminal background check. Any applicant that has been incarcerated, received a felony conviction, or was under community control for a felony conviction within 7 years of applying, will not be eligible to enter the Apprenticeship Program.
6. Applicants will be drug tested during the selection process, at some point prior to indenture, and must show a negative drug screen. Additionally, all indentured applicants shall be subject to random drug testing as outlined in the Apprenticeship Standards and the negotiated Union Contracts.
7. Applicants must show proof of a valid driver's license and obtain at a minimum a class B CDL permit with air brake endorsement prior to the beginning of the pre-admission orientation.
